



## **ArCS II Overseas Fellowship Program 2022 Mid- and Long-Term Program for Practitioners Application Guidelines**

### **1. Outline**

In accordance with the objectives of the Arctic Challenge for Sustainability II (ArCS II) project\* (<https://www.nipr.ac.jp/arcs2/e/>) we implement programs for the support of early career professionals. The ArCS II project provides funding to early career practitioners belonging to Japanese organizations to support their participation in international conferences for making presentations and collecting information, as well as their stay at overseas academic, public, and private organizations for conducting research and expanding contacts along with fieldwork trips. We expect that these mid-to-long-term travel programs will stimulate further research by early career professionals and will help them expand their personal networks at the international level.

In FY 2021, since many international conferences were conducted online due to the global expansion of COVID-19 pandemic, we supported participation in international conferences held online and in Japan, as well as taking online courses. Although it is expected that the COVID-19 pandemic will continue to affect academic collaboration this year, we will accept applications for mid-to-long-term travel programs (1 to 6 months) as well as short-term travel programs (1 month). We will also support participation in international conferences held online or in Japan.

## **2. Research fields, project types, travel period**

### **(1) Research fields**

All fields related to the Arctic

### **(2) Project types**

- 1) Visiting overseas universities, research institutions etc. related to the Arctic research for conducting research, fieldwork etc.
- 2) Participation in international conferences, taking courses for collecting information, building contact networks, acquiring new knowledge and skills etc.

\* 2) may be added as an option to 1) (applications for 2) only are not accepted).

\* In FY 2022, participation fees for international online conferences and other events are also covered.

### **(3) Program period**

Generally, from 1 month up to 6 months.

## **3. Number of fellowships to be awarded**

Several positions are available for this program.

## **4. Eligibility**

A practitioner who belongs to a Japanese company, a Japanese governmental agency or an NPO (including self-employed individuals, such as freelance journalists) and who is under the age of 40 at the time of application.

## **5. Host institutions**

When applying for the program, applicants need to specify the overseas academic, public or private organizations engaged in the Arctic-related research, which they wish to visit. Please note that under the conditions of the mid-to-long-term travel programs you cannot apply for funding for the participation in international conferences and taking courses only.

## **6. Host researchers**

Host researchers are researchers from the institutions the applicants plan to visit and who will be responsible for hosting the research visit/activities. When applying for the program, the applicants must specify their host researchers and attach a summary of their academic profile and achievements (free format).

## **7. How to apply**

### **(1) Application documents**

Please submit the following documents (1 to 8, one copy each). If you are employed on a particular grant, please ensure that your application will not result in a conflict of duties with respect to your contract.

- 1) Application form (Form A)
- 2) Certificate of employment (free format)
- 3) Copy of a document specifying the residence status (residence card, special permanent resident certificate etc. – for foreign nationals)
- 4) Letter of acceptance (host consent) (Form B)
- 5) Host's professional profile and achievements summary (free format)
- 6) Research roadmap (Form C)
- 7) Budget plan: please submit documents that provide an overview of the conference, the registration fees, the PCR test expenses, etc. if you need funding for covering these expenses (Form D)
- 8) Information on the destination immigration and travel restrictions for travelers from Japan (copy of the relevant web pages of the ministries of foreign affairs etc.).

\* Please submit this information even if there are no immigration and travel restrictions.

### **(2) Application and travel period**

(1<sup>st</sup> call)

*Application period:* 28 March 2022 – 9 May 2022, 3 p. m. (JST)

*Travel period:* mid-June 2022 – late March 2023

### **(3) Application method**

Please send a complete set of application documents converted into a PDF file to the following e-mail address:

## **8. Selection criteria and notification of the results**

The ArCS II Priority subject 1 working group “Capacity Building and Research Promotion” assesses the applications and makes the selection. The applicants will receive notification of the results approximately one month after the end of the application period by e-mail (sent to the e-mail address specified in the application form).

Please note that as part of the assessment process, if the assessor has questions in concerning the application content or requests plan improvements, the applicant may be further interviewed in writing.

For reference in preparing the application form, the following assessment criteria are used.

### **(1) Requirements**

The applicant

- has obtained the consent of their current supervisor
- has met the conditions related to the research fields, eligibility and program period
- has provided materials that may be used as sources for the verification of the research plan.

(2) Assessment criteria

- Does the application suit the purpose of the ArCS II project?
- Does the application provide a detailed description of the research objectives and plan?
- Is the applicant well prepared to carry out the project described in the application?
- Is the budget consistent with the research objectives and plan?
- Is the applicant's project, if supported by this program, likely to further their career in the Arctic-related field?
- Does the applicant have sufficient language and communication skills?
- Does the applicant have sufficient experience and ability to carry out the research plan?
- Are the applicant's achievements commensurate with their work experience and career?

(3) Other

- Those who have applied, whose application has been accepted and who has started/completed their travel program supported by GRENE, ArCS or ArCS II projects are eligible for this program.
- All applicants are invited to apply again next year regardless of whether they are accepted for this year's program or not.

## **9. Process for successful applicants**

The program procedures for successful applicants are as follows. Program participants must start the necessary procedures following the instructions from the specialists in charge of the ArCS II program at Hokkaido University.

(1) Orientation

All successful applicants will need to attend an orientation session that will allow the coordinators to ask the applicants about their travel plans and instruct them on the administrative procedures.

(2) Administrative procedures

Successful applicants will receive forms, such as a bank-account registration form, along with the program guidebook.

Please follow the guidebook to complete the administrative procedures.

## **10. Covered expenses**

In accordance with Hokkaido University's regulations, the following expenses will be covered.

- 1) Travel: round trip between the applicant's institution and the visiting institution.
- 2) Accommodation: in accordance with the rules of this program. Please note that applicants are responsible for reserving their own accommodation.
- 3) Travel authorization-related costs: please note that applicants are responsible for taking the required procedures.
- 4) Other: participation fees of the international conferences and/or courses, etc. as specified in the research plan.

## **11. Restrictions on program support due to COVID-19 and the related expenses**

If the planned travel of a selected applicant becomes impossible due to COVID-19, his / her programs will be cancelled.

Cancellation charges for flight tickets, accommodation, travel insurance, and PCR testing costs, along with any costs incurred in association with the need to self-quarantine after returning to Japan, such as accommodation fees and daily allowances, are covered by Hokkaido University.

Travel restrictions: participants are not allowed to travel to the following countries / regions. It is required that both Hokkaido University and your current organization approve all travel.

- Countries prohibiting the entry of travelers from Japan.

The following costs are NOT covered by Hokkaido University.

- Any costs incurred in association with the need to self-quarantine, such as accommodation fees and daily allowances, after arriving at the destination.

## **12. Travel insurance**

All participants must be covered by overseas travel insurance contracted by Hokkaido University during their visit. Basic insurance premiums, as listed below, are covered by the university:

- 1) death from injury / disease
  - 2) disability from injury
  - 3) liability
  - 4) medical treatment / rescue expenses
- (including those related to COVID-19)

## **13. Personal information**

Personal information provided in the application documents will be treated with the utmost care and used exclusively for conducting procedures by Hokkaido University and the ArCS II project. All submitted applications will be disposed of by the office after the selection is completed. With respect to the successful applicants, their names, affiliations, and the reports submitted after their return to Japan will be made public.

## **14. Participant obligations**

### **(1) During the program**

Program participants have an obligation to commit to their duties as specified in their plans submitted in the application documents

### **(2) Upon completion of the participant's program**

1) *Report submission and disclosure obligation*

Participants must submit a report in the prescribed form to Hokkaido University and the ArCS II office within two weeks at the end of the program. The submitted reports will be published on the ArCS II website.

2) *Presentation of the results*

Upon completion of the program, participants will be requested to organize meetings and present their program research results.

\* Travel expenses for the participants of these meetings will be covered by Hokkaido University.

3) *Cooperation requirements*

Participants are required to cooperate with Hokkaido University and the ArCS II office by responding to a survey concerning the ArCS II-supported Arctic research and specialist training.

4) *Participation in information exchange with the community*

Participants are also required to participate in the SNS community and gatherings with other ArCS and ArCS II program participants.

## **15. Compliance requirements**

Participants must comply with the following rules during and after their visit:

- 1) all participant obligations (outlined above)
- 2) not accept any other financial support that covers the costs provided by this program
- 3) not obtain fraudulently any monetary benefits
- 4) not use the research funds fraudulently
- 5) not act contrary to public order and morals

Hokkaido University may retroactively cancel the acceptance, suspend funding and request to repay it if the university finds that the participant has violated any of the compliance requirements listed above or below.

- 1) If the participant is unable to continue their research due to illness.
- 2) If there is a serious issue with the research progress, and it is judged that achieving the expected goal is either impossible or extremely difficult.
- 3) If a serious misstatement is found in the application documents.
- 4) If the participant is found to be unqualified for the program.
- 5) If the participant is found guilty of research misconduct, misuse of research funds, or acts against public order and morals in the past.
- 6) If the participant has made unauthorized changes to the plan, such as temporarily returning to Japan or shortening the duration of the planned program.
- 7) If the participant has failed to follow the instructions given by Hokkaido University and violated the conditions stipulated in the program guidebook.

After their acceptance of their application, successful participants must submit a written pledge to comply with all the requirements.
